WHEREAS, the Tribal Council realizes there is an advantage for all parties, by participating with, training and exercising with other Recognized Indian Tribes in the State for the purpose of Emergency Management, and

WHEREAS, The Tribal Council does also recognize that planning, exercising, individual and collective preparedness and maintaining a Point of Contact (POC) is of the utmost importance for continued survival of the Tribe and it's Members and employees, and

WHEREAS, The participation of the Snoqualmie Tribe with the other member Tribes of the NWTEMC, will facilitate the above;

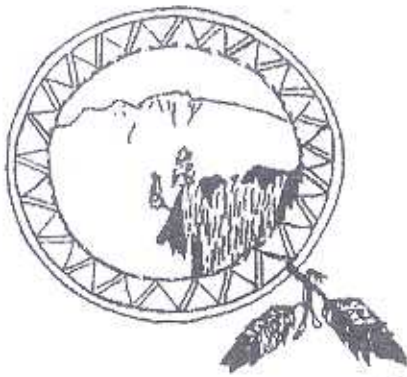
